WE PLACED ONE SUCCESSOR MOBILITY SERVICE DOG AND ONE FACILITY SERVICE DOG WITH A SPECIAL EDUCATION PROFESSIONAL WHO WORKS WITH DISABLED CHILDREN. WE SUPPORTED POST ONE YEAR PARTNERSHIP REMEDIAL TRAINING.
